## 6. Action Items

### a. Unified Planning Work Program

Mr. Warren motioned to approve the following amendments and/or administrative modifications to the Unified Planning Work Program:

- i. Amendments
- ii. Administrative Modifications: Revisions to FHWA Task 2 explaining that a new TIP and PPP are not being developed but rather amended as needed during FY 24. Updated language specifying the party to perform work on each task. No changes to any funding amounts.

There was a second by Mr. Trosclair and the motion carried.

### b. Transportation Improvement Plan

Mr. Clement motioned to approve the following amendments and/or administrative modifications to the Transportation Improvement Program:

- i. Amendments
  - 1. H.013403 LA 20 & LA 304 SIDEWALK IMP (CHACKBAY): Remove Engineering phase \$40k in STP50-<200k at 80/20 in FFY 2023 remove Construction phase \$262,710 in STP50-<200k at 80/20 in FFY 2024.
- ii. Administrative Modifications
  - 1. CANAL BOULEVARD OVERLAY: Jackson Street to LA 1: Move design phase of \$146,560.00 STP50-200k from FFY 2023 to FFY 2024.

There was a second by Mr. Warren and the motion carried.

### c. Metropolitan Transportation Plan

Mr. Arabie motioned to approve the following amendments and/or administrative modifications to the Metropolitan Transportation Program:

- i. 1% annual reduction in fatalities from a 2022 baseline of 37 to a target of 36 in 2024.
- ii. 1% annual reduction in serious injuries from a 2022 baseline of 35 to a target of 35 in 2024.
- iii. 1% annual reduction in fatality rate from a 2022 baseline of 2.051 to a target of 2.011 in 2024.

- iv. 1% annual reduction in serious injury rate from a 2022 baseline of 1.919 to a target of 1.881 in 2024.
- v. 1% annual reduction in non-motorized fatalities and serious injuries from a 2022 baseline of 13 to a target of 13 in 2024

There was a second by Mr. Warren and the motion carried.

- d. Carbon Reduction Project Selection Process  
Mr. Manning discussed. Mr. Trosclair motioned to approve. There was a second by Mr. Arabie. The motion carried.
- e. HTMPO Proposed Smoothed Urban Boundary Area
